Parents will be asked to pick up any child who cries excessively &/or refuses to participate in the class. There are NO REFUNDS or RESCHEDULES ... We ask that you please be totally truthful in completing this form to insure the best possible experience for your child.

RELEASE: I agree on behalf of my child to accept for use, as is, the rental equipment to be furnished by the BMRi SRS Rental Dept. and accept full responsibility for the care of the equipment while in my child's possession, and agree to be financially responsible to reimburse BMRi at full retail value for any loss or damage, other than reasonable/normal wear regarding the equipment. I agree to return all rental equipment at the designated place and time and further agree to pay any "late equipment charges" incurred. I accept & clearly understand that skiing/riding is a hazardous sport which presents RISK of INJURY or DEATH, that injuries are a common & ordinary occurrence of the sport. I freely assume those risks for my child. I understand that the binding systems cannot guarantee the user's safety. I understand that the Ski/Board-Boot-Binding system will not release at all times or under all circumstances where release may prevent injury to any part of the skier's body, nor is it possible to predict every situation in which it will release and it is, therefore, no guarantee of safety to any portion of my child's body. To the fullest extent allowed by law, I hereby agree to release, indemnify, and hold harmless/blameless Beech Mountain Resort, Inc. (BMRi) and all manufactures and distributors of this equipment, and their owners, agents, and employees from any and all liability for damages and injury or death to my child or to any other person or property which may result from the selection, adjustment and use of this equipment and I waive my & my child's right(s) to present any legal claim or suit against these persons, whether based upon negligence, breach of warranty or any other legal theories. I further agree to defend and indemnify providers for any loss or damages, including any that may results from claims or lawsuits for personal injury, death and property loss and damage related in any way to the use of this equipment. This agreement is governed by the applicable laws of this state. I agree that all disputes arising under this contract and/or from any use of the facilities at Ski Beech/BMRi shall be litigated exclusively in NC, in Watauga County, or in the United States District Court for North Carolina. I also understand that any misrepresentation that is contrary to current policy and expectations may result in the removal of my child from the group. I further understand & agree that The BMRi Snow Kamp & TRAXX will provide proper instruction for the use of the rental equipment my child will receive, and I further agree their technicians will verify the visual indicator settings for the rental equipment my child will receive.
